



  - to commit on arranging interviews or hire the students having CoE certificates


#### **Activities and Obligations of GCET**

  - GCET Personnel shall submit all related work carried out under this MoU to SLS
  - GCET Personnel shall not disclose any information related to work carried out under this MoU to any Third Party for the period of Three (3) years.

#### Governing Law

This MoU shall be construed in accordance with the laws of India.

#### Assignments

Neither Party may assign or transfer the responsibility or MoU made herein without the prior written consent of the other Party.

#### Intellectual Property (IP) Rights

Rights related to any background IP provided by SLS is owned by SLS and regarding Publications, Patents, Royalty, Ownership or such other IP Rights of software/ design/ product developed under the scope of this MoU, shall be decided by the two parties by mutual consent in writing.

#### Miscellaneous

Both Parties shall not, during the term of this MoU, directly or indirectly, solicit or offer employment or engagement to any of the personnel of other Party without the prior consent in writing of that other Party.

No failure to exercise and no delay in exercising, on the part of a Party, and right, remedy, power or privilege hereunder shall operate as a waiver thereof, nor shall any single or partial exercise of any right, remedy power or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power, or privilege. The rights, remedies, power, and privileges herein provided are cumulative and not exclusive of any right, remedies, powers, and privileges provided by law.





#### Amendment



Either Party can amend the MoU by written notice to other Party before thirty (30) days and agreed by both Parties.

### Address of Parties and Communications

All notices and other communications required or permitted under this MoU shall be deemed to be properly given when given in writing and sent by registered post or by facsimile and confirmed by mail, postage prepaid, to the designated party at the addresses stated in preamble section.
